

## Opting customers into text messaging for PawnMaster Versions 10.06 and earlier.

### Step 1

Enter the customer cell number on the Customer Info tab.

### Step 6

To disable this customer from receiving marketing text messages you must go back to the Customer screen and on the "Additional Info" tab and UNCHECK the "Sales" box.
